RIGHTS OF THE DATA SUBJECT
(Articles 15 to 22 and Article 13 of the GDPR)

We would also like to inform you of the following rights you may exercise with regard to the Data Controller:

- Right to access:** The data subject has the right, in accordance with Article 15 of the GDPR, to request access to their personal data from the data controller.
- Right to rectification:** The data subject has the right, in accordance with Article 16 of the GDPR, to request the data controller to rectify their personal data.
- Right to erasure:** The data subject has the right, in accordance with Article 17 of the GDPR, to request the data controller to erase their personal data.
- Right to restrict processing:** The data subject has the right, in accordance with Article 18 of the GDPR, to request the data controller to restrict the processing of data relating to them.
- Right to object:** The data subject has the right, in accordance with Article 21 of the GDPR, to object to the processing of their personal data.
- Right to withdraw consent:** The data subject has the right, in accordance with Article 7(3) of the GDPR, to exercise their right to withdraw consent.
- Additional notes:** The data subject may also lodge a complaint with a supervisory authority (e.g. the Data Protection Authority).
- Presence of an automated process:** The processing is not based on automated decision-making.
